Subject: MINUTES OF THE 8th MEETING OF THE WORKING GROUP FOR DEVELOPMENT OF DOING BUSINESS REFORM AGENDA

The 8th meeting of the Provincial Working Group on Doing Business Reform was held under the chairmanship of Chief Secretary, Punjab on Wednesday, 27th September, 2017 at 14:00 (hrs.) in the Committee Room of S&GA Department, Punjab Civil Secretariat, Lahore. The objective of the meeting was to review the reform actions in process by Government of the Punjab against the relevant indicators of Doing Business including Business Registration; Construct Permits; Contract Enforcement; and Property Registration. - 2. The meeting started with recitation from the Holy Quran, followed by welcome remarks of Chief Secretary Punjab. The Chief Secretary Punjab urged all the stakeholders to start analyzing the improvements made against doing business indicators. Referring to Chief Minister's visit to Turkey, the Chair informed that Deputy Prime Minister of Turkey, who also looks after Turkey's Doing Business Reform Agenda, held a meeting with CM Punjab. During the meeting the Deputy PM proposed to share Turkey's action plan with Government of the Punjab (GoPb) and offered to provide technical assistance and support to GoPb with regard to improving doing business indicators.
- 3. This was followed by remarks of Minister for Finance. She added that many initiatives to improve the doing business rankings have been proposed by Government of the Punjab, and many have already been implemented. However, she mentioned that there is a dire need to monitor and implement the on-going initiatives with pace. She also urged all concerned departments/agencies to gear up and expedite the on-going reforms process before the visit of Turkey's Deputy Prime Minister to Lahore, in which briefing on Government of Punjab's Doing Business Reform process is expected.
- 4. Secretary, P&D Department appraised the participants on the decisions taken in the last meeting. He then briefed the Chair regarding broad contours of the draft MoU to be signed with Turkey upon visit by Deputy PM of Turkey to Lahore. He also gave a detailed presentation on the action plan of Government of the Punjab for 2017-18 prepared in consultation with the World Bank and shared with all departments for bringing improvements in the rankings of four indicators. Secretary P&D also highlighted the pending action items that required immediate attention of the Chair and Heads of the implementing agencies. Furthermore, going over the action plan, indicator-wise, the concerned departments/agencies also briefed the Chair regarding the progress made so far on respective doing business indicators.
- 5. The presentation and briefing by departments was succeeded by a discussion session, in which all members actively participated and shared their insights. After detailed deliberations, the following decisions were taken:

- i. All concerned departments/agencies to immediately nominate a senior ranking officer as focal person, to monitor and implement the action plan of doing business reform agenda against the concerned indicators, under intimation to P&D Department, and also submit progress reports on the ongoing reforms and the initiatives already completed within three days.
- ii. P&D Department in consultation with the concerned departments, to list out completed reforms process and on-going reforms, in order to identify issues if any and expedite them.
- iii. Punjab Land Records Authority (PLRA), Board of Revenue Punjab (BOR) and Urban Unit to present their progress/initiatives envisaged to be taken this year to improve property registration indicator in urban Lahore in line with Doing Business methodology in the next meeting.
- iv. BOR to review the amendments on Registration Act and Land Acquisition Act proposed by the Legal expert engaged by P&D Department and initiate the consultative and legislation process in this regard.
- v. PESSI to consider and initiate the process of reducing the frequency of submission of monthly contributions to bi-annually or yearly.
- vi. Finance Department to expedite the process of online/e-payments in consultation with SBP, AG and Treasury and set a time line for setting up the online payments platform.
- vii. Law Department, Government of the Punjab to expedite the process of legal review/ amendments in the relevant laws under this Program which pertains to the Law Department.
- viii. Separate presentation on improving paying taxes indicator to be given by E&T and Finance in the next meeting.
- ix. P&D Department to hold frequent meetings with the Administrative Departments to review and expedite the reforms in process, before the visit of Deputy PM of Turkey.
- x. LG&CD Department and PITB to quickly complete / finalize all arrangements to start issuance of construction permit from E-Khidmat Centre at Lahore.
- 6. The Chair in his closing remarks emphasized that all departments are advised to assign the highest priority to the doing business reform agenda as it is through such interventions that Punjab will not only aid in improving Pakistan's global ranking, it will also help generate positive messages for the private investors. He also mentioned that departments should prioritize and focus on low hanging fruits and reform items which are near to completion should be immediately completed. He urged all departments/agencies to accelerate the pace for execution of the said action plan and desired that progress on the implementation of doing business indicators should be regularly reviewed by the respective Secretaries to ensure that the action plan is implemented well before the cutoff date.
- The meeting ended with a mutual vote of thanks.
