- 1) Companies Ordinance 1984 review- Discuss the upcoming changes related to
 - a. CEO registration
 - Removal of bank account requirement (bank to notify the company incorporation authority if a company has opened an account with the bank. Review banking laws, income tax ordinance)
- 2) Facilitation for women entrepreneurs
- 3) Publish registration statistics on SECP website
- 4) Are records of registered companies publically available? A company profile with company incorporation certificate?
- 5) Discuss merger of other procedures
- 6) Make it mandatory to merge step 1 and 4
- 7) Establish a formal mechanism for monitoring and enforcement of reform actions
- 8) Discuss how name reservation can be eliminated and name search can be done in real time
- 9) Discuss with FBR on how to eliminate steps related to tax related registrations
- 10) Presentation by Lars- Show that for recommendation and give best practices

Registering Property:

- 1) Absence of transparency reforms
 - a. Put checklist of required documents on website
 - b. Registration statistics on website
 - c. Develop complaint submission and resolution mechanism
- 2) Publicise that requirement for advertisement in the newspaper is not a requirement.
 - a. It should be put on the website of LRMIS
 - b. Any such advertisement should not be accepted as part of the registration application package.

Construction Permits:

- 1) Risk management
 - a. Review the regulations for risk based permitting process
- 2) Clarify EPA requirements and publish them on LDA and TMA website for Lahore and SBCA for Karachi
- 3) Design Framework for making rules and regulations standard for the federal and provincial authorities
