Subject: MINUTES OF 12th MEETING OF THE PROVINCIAL WORKING GROUP OF EASE OF DOING BUSINESS REFORMS AGENDA OF PUNJAB – SPRINT-III ACTIVITIES

12th meeting of the Provincial Working Group on Ease of Doing Business (EODB) Reforms in Punjab was held on 23.11.2018 (Friday) at 02:30 PM under co-chairmanship of Chief Secretary, Punjab and Minister for Finance, Government of the Punjab, and several senior representatives from relevant implementing agencies. The objective of the meeting was to review the implementation status of Doing Business Reforms Sprint-III (**List of participants attached at Annex-A**).

- 2. The meeting started with welcome remarks by Chief Secretary, Punjab followed by a presentation by Mr. Iftikhar Ali Sahoo, Secretary, Planning & Development Department who highlighted the key reform actions under Sprint-III that are in process by the relevant implementing agencies.
- 3. After detailed deliberations with the key implementing agencies, the following decisions were taken:

4. Chair advised all implementing agencies to maintain intensive and regular interactions with the private sector including potential survey contributors. Stakeholder engagement workshops should be organized regularly to apprise the private sector of reforms so the same can be captured in the ease of doing business survey which will be starting in January-February 2019.
