### Subject: MINUTES OF THE 2<sup>nd</sup> MEETING OF THE WORKING GROUP OF PUNJAB JOBS & COMPETITIVENESS (J&C) PROGRAM FOR RESULTS (P4R)

The second meeting of the Working Group of Punjab Jobs & Competitiveness Program for Results was held under the chairmanship of Secretary P&D on 25.04.2016 (Monday) at 03:00 PM in the auditorium of P&D Department. The meeting was convened to review the present status of PC-1s being prepared by respective implementing agencies of the Program and other related matters. The list of participants is at **Annex-A**. The discussions held in the meeting and decisions taken are reproduced below;

1	DLI-1: Business Registration	Department of Industries – DG Industries	The representative from DOI explained that the PC-1 was being prepared by DG-Industries' office and the same would be submitted within a week. The chair observed that the inputs of business registration mapping being conducted by E&Y should be made part of business registration PC-1 and the PC-1 may also be shared with LCCI team members working on ease of doing business reform agenda. The chair also observed that LCCI recommendations on business registration process may also be made part of this PC-1.

			It was also explained that in the brainstorming session held at PRMP regarding construction permit issuance, it was decided that a separate PC-1 for LG&CD/TMA would be prepared to execute program interventions since TMAs hold majority of the area of Lahore for issuance of construction permits. The chair also observed that the allocation for next year ADP may be indicated by LG&CD to undertake program activities after approval of PC-1.
