## Subject: MINUTES OF MEETING ON SPRINT-III OF EASE OF DOING BUSINESS REFORM AGENDA (EODB)/DLI-1 OF JOBS & COMPETITIVENESS (J&C) PROGRAM

A review meeting on Sprint III of Ease of Doing Business Reform Agenda was held on 03.10.2018 (Wednesday) at 10:00 AM under the Chairmanship of Secretary, Planning & Development Department, Government of the Punjab in the Auditorium of P&D Department. The meeting was convened to discuss Sprint III activities of Ease of Doing Business. The objective of the meeting was to review the Sprint III reform action plan under the Doing Business Reform Agenda (List of Participants attached).

- 2. The meeting started with welcome remarks by Secretary, Planning & Development Department followed by a detailed presentation by Program Director, Program Implementation Unit (PIU) on the implementation status of Sprint III activities under Ease of Doing Business Reforms Agenda.
- 3. After detailed deliberations on Sprint III activities with the key implementing agencies, the following decisions were taken:
